Definitions

Diaspora¹: Refers to people who have migrated from their homeland to other geographic locations for employment, business or any other purpose.

Non-Resident Rajasthani (NRR)²: means any person either he/ she/ himself/ herself has or his/her forefathers had a native place in Rajasthan, and who is presently domiciled elsewhere in the country or abroad owing to business, profession, employment or calling.

Rajasthan Chapter³: means a support centre of the Rajasthan Foundation (RF) to be known as Chapter of the RF for a local area comprising metro city and periphery thereof or similarly in other city in India or abroad where NRRs are residing and engaged in various businesses, professions, vocations and calling, in sizable numbers and considerably contributing to the economy of the said local areas.

Introduction

The Rajasthani Diaspora comprising Non-Resident Rajasthanis traces its origin to the historical periods of migration influenced by factors like foreign intervention, trade and commerce, and business opportunities that connected Rajasthan with different parts of the world. These individuals ventured beyond the borders of Rajasthan carrying with them the values, vibrant culture and enduring spirit of Rajasthan. Over the years, NRRs have made remarkable achievements in diverse fields such as Business, Education, Arts, Science, Public service and more, while maintaining a deep and lasting connection to Rajasthan.

As this global community continues to grow, so does the need for a structured and meaningful way to stay connected. NRRs often seek opportunities to contribute to the development of their home State. At the same time, they also look for support, recognition and a sense of belonging.

To acknowledge the need for a sustainable and meaningful connection with the NRRs, the GoR had set up a dedicated organization, 'Rajasthan Foundation in March 2001 under the Rajasthan Societies Registration Act, 1958. The objectives of RF are to strengthen the participation of the Rajasthani Diaspora in the development of the State, facilitating a process of continuous communication and interaction, organizing cultural and educational initiatives, and promoting the well-being of NRRs. It also acts as a bridge between the State Government and NRRs, including their Associations in India and abroad.

Rajasthan Foundation currently operates through its 26 active chapters- 12 international and 14 domestic, reflecting its growing global presence and community outreach. At places wherever there is good presence of Pravasi Rajasthanis, more chapters will be established in times to come.

For providing better linkages & support to NRRs and accelerating their contributions to Rajasthan, State Govt. has recently formed a dedicated department for NRRs- Department of Domestic & Overseas Rajasthani Affairs (DORA).

The NRR Policy 2025 reflects the continuing commitment of the GoR in making strategies and initiatives related to the diaspora that are mutually beneficial. It is designed to meet the evolving aspirations of NRRs, offering them meaningful ways to stay connected with their roots while contributing to the State's development journey.

Objectives of the NRR Policy

- I. To build and maintain strong social, cultural and economic ties with NRRs by creating a supportive environment for their contribution in investment, trade, knowledge sharing, research and philanthropy.
- II. To build and strengthen a Global Rajasthani Community, reconnect NRRs to their roots, and maintain a strong sense of belonging to the Rajasthani identity through regular cultural and community activities.
- III. To recognize and honour the achievements of NRRs in their respective fields, and the work done for the development and welfare of their homeland, Rajasthan.
- IV. To help and support NRRs through effective grievance redressal mechanisms and improved coordination with relevant authorities in the GoR, GoI and Indian Missions overseas.

Title & Commencement

- I. This policy shall be titled as "Non-Resident Rajasthani Policy of Rajasthan 2025".
- II. The policy shall come into effect from the date of its notification in the Official Gazette and shall remain in force until it is amended, superseded or quashed by the State Government.

Policy Pillars

The pillars emphasize a comprehensive and strategic approach of the NRR policy, focusing on achieving objectives, building connections, celebrating contributions, driving initiatives and ensuring support for NRRs. To further institutionalize the effort, a dedicated State Government Department shall be set up to serve as the central coordinating framework to facilitate the goals outlined in the policy and implement initiatives under each of the following five strategic pillars:

- I. Accelerate: The pillar focuses specially on creating an ecosystem that facilitates NRRs' investments, making it easier for them to find business opportunities, connect with Government Departments and get support for their ideas for the overall economic development of the State.
- II. Bridge: The pillar facilitates a link between Rajasthan and its global diaspora to build a lasting

- connection with NRRs through a Dynamic Outreach Program using social media, newsletters, livestreams, conclaves and events.
- III. **Celebrate**: The pillar preserves and promotes rich Rajasthani culture, heritage and art with NRRs through vibrant festivals, exhibitions, cultural and educational initiatives. It aims to celebrate and honour the achievements of NRRs in their present country and in Rajasthan.
- IV. **Drive**: The pillar mobilizes the Rajasthani Diaspora to contribute specifically to Rajasthan's socioeconomic development through philanthropic activities in areas such as Infrastructure development, education, healthcare, Tourism, Art and Culture, environment protection, community building and other social services, thereby leveraging local initiatives.
- V. **Ensure**: The pillar prioritizes providing assistance to NRRs through Grievance Redressal Platforms, support systems and responsive administration.

1. Pillar 1: Accelerate

A. NRR Investment Facilitation

This initiative aims to mobilize the investment potential of NRRs by promoting a supportive ecosystem for trade and infrastructure development in the State. Through strategic partnerships, streamlined facilitation and targeted outreach, the RF seeks to attract and sustain diaspora-led investments across key sectors. RF shall:

- I. Focus on promoting investment opportunities in Rajasthan across key sectors by leveraging the global network of NRRs for lead generation and investor engagement, while organizing networking events to connect NRR investors with local businesses and Government Departments.
- II. Interact with active RF Chapters/ NRR Associations, which operate in various Indian states and internationally, for information exchange, business partnerships and bilateral trading relationships.
- III. Organize Knowledge Series with NRRs in collaboration with different Government Departments/ institutions to promote various schemes and policies of the State Government.
- IV. To highlight the benefits and success stories of NRR investment in Rajasthan at various platforms and through social media.
- V. Establish a dedicated NRR Investment Facilitation Cell within the Department of Domestic & Overseas Rajasthani Affairs, staffed with 'Investment Liaison Officers' responsible for end-to-end coordination with NRRs for their investment-related activities. This Cell shall organize physical and virtual Pravasi Meets for the generation of leads, develop a follow-up mechanism to track investment proposals and engage proactively with the Bureau of Investment Promotion and relevant State Government Departments to ensure timely resolution of investor issues and seamless facilitation.
- VI. Coordinate with both overseas and Indian RF Chapters to appoint 'Investment Coordinators' who will actively identify and share investment leads with the RF and also facilitate the investors with knowledge of operational schemes/ policies of GoR to promote investment in the State.
- VII. Promote the establishment of NRR Investment Advisory Councils within RF Chapters, comprising sectoral experts and business leaders from the diaspora. These Councils shall serve as strategic think tanks, producing actionable insights, sector-specific investment roadmaps and policy recommendations. RF will organize focused interactions with these Councils and ensure that key recommendations are shared with relevant Government Departments.

- VIII. Leverage the global Rajasthani diaspora's domain expertise and networks to guide early-stage and growth-stage startups in Rajasthan through 'Global Expertise for Local Innovation', in coordination with Department of Information Technology and Communication.
 - IX. Enable Rajasthan startups to access international markets through diaspora-supported entry point.
 - X. Encourage diaspora investment for startups across sectors like Agri & Food Processing, Auto & Auto Components, Chemicals & Petrochemicals, Education & Skill, Electronic System Design & Manufacturing (ESDM), Gems & Jewellery, Glass & Ceramics, Handlooms & Handicrafts, IT & ITeS, Logistics & Warehousing, Mines & Minerals, Renewable Energy, Textiles, Tourism etc.
 - XI. Promote Public Private Partnerships (PPP) for Centres of Excellence and Primary Health Care, facilitate telemedicine, e-mentorship, and short-term clinical exchanges of specific expertise, establish joint research collaborations between diaspora universities/institutions and medical colleges in Rajasthan, and develop innovation hubs linking diaspora entrepreneurs with local health startups in coordination with Department of Medical and Health.

2. Pillar 2: Bridge

A. Digital NRR Connect

The initiative aims to build a seamless and interactive digital bridge between NRRs and their home State. RF shall:

- I. Facilitate regular digital interactions between NRRs and key Government authorities. These engagements may include video conferences, video messages, Q and A forums etc., to build trust, share investment opportunities and strengthen the emotional and developmental linkages connection between NRRs and the State.
- II. Release regular newsletters and updates on social media platforms, with NRR participation, to keep them informed and engaged with upcoming events, festivals, cultural events, investment facilitation schemes and initiatives of the GoR and RF.

B. Pravasi Rajasthani Divas

To honour and celebrate the contributions of the global Rajasthani diaspora, the RF shall celebrate Pravasi Rajasthani Divas. This celebration shall serve as a flagship event to recognize the achievements of NRRs and strengthen their cultural and emotional ties with Rajasthan. PRD will feature a series of celebratory events, including but not limited to:

- Award ceremonies to recognize outstanding achievements of NRRs in areas such as Business,
 Education, Arts, Science, Health care, Philanthropy, Public Service etc.
- II. Interactive sessions and panel discussions with diaspora leaders, entrepreneurs and youth on various Themes in order to explore opportunities for engagement and collaboration.
- III. Networking opportunities to strengthen connections among NRRs and between the Diaspora and the GoR.
- IV. Exhibitions and showcases of Rajasthani Crafts, Cuisine and Tourism to promote the State's rich heritage globally.
- V. Cultural performances showcasing Rajasthani Music, Dance and Traditions, instilling a sense of belonging.

C. Engagement with NRR Associations

The Engagement with NRR Associations program aims to unify and strengthen Rajasthan's global diaspora network by fostering collaboration with NRR Associations across countries and States. RF shall:

- Act as an umbrella organization to integrate and coordinate with national and international NRR
 Associations.
- II. Conduct events with NRR Associations, held either physically at the state, regional or international level or virtually through digital platforms such as video conferences. These events shall follow rotating agendas focused on addressing NRR-related challenges and concerns, exploring new opportunities in Investment, Industry, Innovation, Tourism, Healthcare, Arts, Culture, Philanthropy etc.
- III. Encourage Associations to share best practices, resources and strategies for sustained engagement with Rajasthan and among themselves.

D. Mapping of Diaspora

The program aims to build a comprehensive understanding of the global Rajasthani community by collecting accurate data. RF shall:

- I. Develop a comprehensive framework to gather reliable data on diaspora demographics, including location, education levels, professions, skills, business interests and investment potential.
- II. Maintain a dynamic, secure and regularly updated diaspora database which shall serve as a strategic resource for targeted engagement, policy planning and investment promotion.

E. RF Chapters

RF Chapters, already established in various cities across India and abroad, and to be established in additional locations, aim to encourage the participation of the Rajasthani diaspora in the socio-economic development of the State of Rajasthan. RF shall:

- I. Promote formation of dedicated committees within each RF Chapter to focus on key areas such as Investment facilitation, Cultural, Educational, Tourism promotion, Philanthropic engagement and Youth outreach.
- II. Appoint dedicated Ambassadors/ Coordinators for Culture, Philanthropy, Investment, Educational and Social Initiatives under specific committees to globally promote tourism, heritage and key development efforts, ensuring more focused and strategic outreach.
- III. Facilitate coordination with national and international NRR Associations in respective states and countries for exchange of best practices and innovative ideas and unifying the Rajasthani community globally.
- IV. Promote organization of cultural events, festivals and networking meetups to celebrate Rajasthani heritage and foster connections among NRRs and local communities in RF Chapters.
- V. Facilitate mentorship programs under RF Chapters where experienced NRRs can guide students, startups and professionals.
- VI. Encourage international Chapters to maintain communication with the respective Indian Missions to seek coordination, guidance and support for their initiatives and activities.
- VII. Conduct regular visits or virtual engagements with international and national RF Chapters to organize events, provide policy updates and directly engage with diaspora members to address concerns and strengthen relationships.
- VIII. Identify new locations for establishing RF Chapters based on diaspora density and interest.

 Existing Chapters shall be revitalized through capacity-building and leadership support.

- IX. Require each RF Chapter to prepare a comprehensive Annual Action Plan with defined roles and responsibilities, time bound deliverables and periodic review mechanism, in consultation with RF.
- X. Provide for review and where necessary, restructuring or dissolution of non-performing RF Chapters with due process, in the larger interest of the State.

F. Global Youth Connect

Reaching out to the next generation of the Rajasthani diaspora shall be an ongoing commitment to build new NRR connections. The RF shall:

- I. Formulate the Jaane Apna Rajasthan Program for younger generations (18-28 years) of the diaspora, to deepen their understanding of Rajasthan's rich culture, heritage, economic growth and industrial transformation. This initiative will include familiarization (FAM) tours to tourist places and industrial hubs and organizing cultural and educational programs etc.
- II. Establish dedicated NRR Mentorship Circles in different countries and Indian states, under RF Chapters, comprising expert NRRs from diverse domains such as Technology, Entrepreneurship, Culture, Education, Arts and Sports.
- III. Promote and facilitate partnerships between these NRR circles and educational institutions to design and implement skill-building workshops, mentorship programs and knowledge exchange sessions like Diaspora Knowledge Hours.
- IV. Conduct regular meetings with NRR Mentorship Circles to coordinate activities, share updates and provide support for organizing impactful youth engagement programs.

3. Pillar 3: Celebrate

A. Celebrate Rajasthan

'Celebrate Rajasthan' initiative focuses on preserving and promoting Rajasthani culture and traditions among the global diaspora. It brings together NRRs through festivals, cultural events and creative campaigns. The aim is to keep the spirit of Rajasthan alive while celebrating the achievements of NRRs. RF shall:

I. Co-ordinate the celebration of Rajasthani and other festivals such as Teej, Gangaur, Diwali, Holi, Makar Sankranti, Mahavir Jayanti, Gurpurab, Baisakhi, Eid, Christmas etc. through both online and offline mode. These celebrations will involve active participation from RF's international and domestic Chapters and NRR Associations.

- II. Regularly disseminate NRRs engagement on the RF official website and social media platforms, and publish the RF newsletter with highlights of NRR-led cultural events, traditional festivals, folk art, notable literary works by NRRs and community celebrations worldwide.
- III. Celebrate Rajasthan Divas and Rajasthan Foundation Day with special programs, cultural showcases, interactive exhibitions, community-led celebrations etc. and engaging with NRRs worldwide.
- IV. Design and distribute culturally themed promotional materials, such as theme songs, diaries, bookmarks, calendars and paper bags—featuring Rajasthani art, motifs and messages aligned with RF's mission.
- V. Publish a visually rich Coffee Table Book showcasing the achievements, stories and contributions of distinguished NRRs across the globe.
- VI. Promote tourism segments among NRRs by positioning Rajasthan as a premier destination for immersive experiences, including wedding tourism, wildlife and eco-tourism, rural and agri tourism adventure tourism, medi-tourism, agri-tourism, MICE tourism and film tourism for diaspora film and documentary makers in co-ordination with the Tourism Department, GoR.
- VII. Organize sports tournaments such as Pravasi Cricket League, Kabaddi, Kho-Kho, traditional Rajasthani board games and Antakshari etc. in local language to engage NRR youth and foster camaraderie through friendly competition in co-ordination with the concerned department.

B. Pravasi Rajasthani Samman Awards

RF shall organize the 'Pravasi Rajasthan Samman Awards' event to recognize, engage and celebrate exceptional and meritorious NRRs. The Awards shall be governed by the guidelines formulated by RF and approved by the State Government. These Awards shall be conferred in a special award ceremony, which may be organized along with a State event for NRRs. The mechanism for the proposed Awards shall be as under:

- I. The Award shall be given to NRRs in multiple categories, including but not limited to Science, Art, Business, Professions, Sports, Films, Social service, Industry, Education, Literature, Music, Health care etc. These categories may be expanded based on decision taken by the GoR.
- II. There will be a Screening Committee and a Selection Committee for recommendation of the names of awardees to the Chairman, Rajasthan Foundation.
- III. RF shall also extend recognition by way of Appreciation Letter/Memento to be conferred at various events to NRRs who contribute to Rajasthan's development initiatives or promote the interests of overseas Rajasthani communities.

- IV. Concessions in the entry fee or allowing free entry to the Awardees to tourist places under the Tourism Department, GoR and the museums under the Art and Culture Department, GoR.
- V. Invitation to the Awardees for select State functions and other events.

4. Pillar 4: Drive

A. Diaspora for Development

The Diaspora for Development program is RF's initiative to harness the philanthropic spirit of NRRs for impactful social and infrastructure projects across the State. RF shall be the nodal agency for networking with NRRs and seeking their financial contributions towards the setting up of schools, colleges, hospitals and community infrastructure in the rural and urban parts of Rajasthan. RF shall also act as a facilitator and connect NRRs, Government Departments and local institutions to cocreate sustainable change across all sectors including priority areas such as Investment and Industry, Technology and Innovation, Tourism, Health care, Education and Social Infrastructure, where NRRs have historically contributed and can further augment the State's development . This includes enabling partnerships with the private sector, academia, public institutions, NGOs, international organizations and skill agencies aligned with Rajasthan's development priorities. RF shall also support diaspora participation through appropriate Public-Private Partnership (PPP) models, public works and facilitate CSR initiatives in collaboration with the Industries and Commerce Department and the concerned District Administration.

RF shall drive and facilitate diaspora for making contributions via Gyan Sankalp portal and Vidyalaya Ke Bhamashah scheme of Education Department, CSR portal of Industries Department and other initiatives across various State Government departments. On the basis of the financial contribution made by the donor NRRs, due recognition will be given to them/ their family members while naming the Government buildings.

Annexure A outlines some proposed sectors and routes through which contributions may be encouraged. However, these are illustrative and shall not limit the range of permissible avenues.

The Rajasthan Foundation, in collaboration with the relevant departments and District Administration, shall identify priority gap areas across sectors and regions where contributions from Non-Resident

Rajasthanis can generate significant impact. RF, together with these stakeholders, will also facilitate the dissemination of this information and coordinate with NRRs and RF Chapters to mobilize their support and engagement in the identified areas.

5. Pillar 5: Ensure

A. Grievance Redressal System

RF shall serve as a point of contact for grievances and issues related to NRRs and facilitate addressing them in coordination with District Administration, Embassies and Ministries of the Gol. The following mechanism shall be adapted to address grievances of NRRs:

- Rajasthan Sampark Portal: NRRs can register their grievances on the Rajasthan Sampark Portal
 of the GoR, which features a dedicated tab specifically for NRRs.
- II. District Nodal Officers: A single point of contact shall be created in every district for addressing issues of NRRs. The functions of District Nodal Officers shall include:
 - a) Coordinate and support the RF in implementing welfare measures and provisions of the NRR Policy.
 - Publicize the grievance redressal mechanism and provide local assistance to families of NRRs in case of emergencies.
 - Facilitate the resolution of issues related to NRRs and their families in Rajasthan with the help
 of District Administration and District level officers of the concerned departments.
 - d) Ensure timely facilitation/resolution of health-related issues of NRR family members through coordination with the Medical and Health Department functionaries in the districts.
 - e) Facilitate repatriation of mortal remains of deceased NRRs in coordination with the RF Chapters, NRR Associations, Embassies, Missions, Ministry of External Affairs and Gol.
 - f) Submission of action report by District Nodal Officers through the District Collector to RF and maintaining a database of all complaints and their status.
 - g) RF shall review pending complaints on regular basis and ensure inter-departmental coordination for the resolution of the same.
- III. **Escalation Matrix:** A structured escalation matrix shall be notified for NRR grievances, defining levels of responsibility, time-lines for each stage and clear pathways for escalation where matters remain unresolved within the prescribed time limits.

IV. Dedicated Helpline: Dedicated helpline numbers for NRRs shall be publicized by RF and District Nodal Officers to facilitate timely registration and tracking of grievances.

B. Overseas Cooperation

Overseas Cooperation shall play a vital role in supporting NRRs during emergencies and promoting mutually beneficial partnerships. RF shall:

- Work in close collaboration with the Ministry of External Affairs and engage with Indian Missions abroad to ensure continuous support for NRRs.
- II. Coordinate with Indian Missions at the time of natural calamities and emergencies to support NRRs in distress, including providing repatriation assistance.

6. Policy Implementation, Review and Monitoring Mechanism

Schemes/programs/guidelines related to each of the above initiatives shall be notified/rolled out as part of the implementation of the Policy. In case the concerned departments require amendments in their respective Rules/sub-rules and notifications for the implementation of this Policy, the same can be done after obtaining due approvals at the appropriate level.

Department of Domestic & Overseas Rajasthani Affairs shall act as the nodal coordinating, monitoring and implementing department. Any matter pertaining to the interpretation of any clause of the Policy shall be referred to the Administrative Department.

A Committee shall be constituted in Department of Domestic & Overseas Rajasthani Affairs (DORA) to periodically review the implementation and assess the impact of the Policy. The committee shall comprise Chief Secretary, Govt. of Rajasthan as Chairman, Secretaries of Industries, Plan & Finance Departments as Members, and Commissioner, Rajasthan Foundation cum Ex-officio Special Secretary, DORA as Member Secretary. State Government may nominate other officials and subject specialists in the Committee, if required.

The Committee shall ensure timely issuance of relevant Government orders by various departments in relation to this Policy. The Committee shall be empowered to take all necessary decisions for smooth implementation of the Policy, such as:

I. To assign roles and targets to institutions involved.

- II. To monitor the progress of all institutions involved.
- III. To interpret and/or relax any provisions of the Policy.
- IV. To frame and/or amend any guidelines or schemes under the Policy.
- V. To review various measures for a favourable environment in the State for NRRs.

I. Shiksha Setu

RF shall promote and facilitate NRR participation in educational institutions (Primary, Secondary, Higher, Technical) and community development by guiding them to impactful projects in collaboration with the Education Department, GoR and District Administration. NRRs may support the educational infrastructure, construction of classrooms, libraries, hostels, digital learning centres as well as the provision of safe drinking water, sanitation facilities, furniture etc. NRRs may also adopt educational institutions and contribute through Gyan Sankalp Portal and also under the provisions of the Sahbhagita schemes of the Education Department.

RF shall also encourage contribution towards digital literacy through computer donation and training programs. Beyond seeking financial support, RF shall promote non-financial engagement, such as volunteering for online classes, career talks and motivational sessions to enrich learning in rural and semi-urban schools.

II. Aarogya Bandhan

RF shall promote and facilitate NRR contributions to strengthen healthcare infrastructure by guiding them to priority projects in coordination with all the agencies of Health Department, GoR including Ayurveda, Unani, Homeopathy etc. NRRs may support the renovation of hospitals, Primary Health Centres (PHC), community health facilities, donation of ambulances, mobile medical vans and essential medical equipment such as diagnostic machines, ICU beds, oxygen concentrators, surgical tools etc.

RF shall also encourage support for organizing health camps in under-served areas and providing targeted aid for vulnerable groups such as orphans, children with disabilities and senior citizens in need. Additionally, RF will promote non-financial contributions such as awareness drives, free consultation and health education initiatives. RF shall coordinate with the Department of Medical and Health to promote initiatives such as Aapni Panchayat Aapno Aspatal and develop them as model centers with NRR contributions and engagement while also mobilizing diaspora globally to support targeted Rajasthan health initiatives.

III. Apni Aanganwadi

RF shall facilitate NRR contributions to strengthen Aanganwadi centres by supporting renovation, sanitation facilities and provision of essential items like toys, furniture, utensils and safe drinking water in collaboration with the Women and Child Development Department, GoR and District Administration. RF shall also promote support for nutrition programs for children (0–6 years) and lactating mothers. NRRs may additionally sponsor local talent—artists, athletes, students and undertake community initiatives.

IV. Apni Virasat

RF shall promote the adaptive reuse of NRR-owned heritage properties by facilitating their transformation into boutique hotels, museums, cafés or cultural spaces etc. in coordination with the Tourism, Art and Culture, UDH, LSG, Revenue, and Panchayati Raj departments, GoR.

RF shall also guide and support NRRs interested in contributing to the promotion of tourism, art and culture through organizing related events or supporting infrastructure development, restoration and beautification of pilgrimage sites, including upgrades like lighting, landscaping, seating, access facilities etc., in coordination with the Devasthan, Tourism, Art and Culture and concerned departments, GoR.

V. Hariyalo Pradesh

RF shall facilitate NRR contributions towards environmental sustainability in maintenance or establishment of forest blocks, forest nursery, wildlife rescue centres, prey base augmentation sites, Luv-Kush Vatika and donation of rescue vehicles in forest divisions. Bird relief centers and Green lungs may be adopted or sponsored. Adaptation of animals in Biological Parks as per the Captive Animal Sponsorship scheme will be promoted in collaboration with the Forest Department.

NRRs may contribute to organising large-scale tree plantation drives in schools and public spaces, installation of solar panels, supporting the development of community parks, promoting rainwater harvesting systems etc. in co-ordination with concerned departments.

These efforts shall be aligned with the State's flagship 'Hariyalo Rajasthan' mission and campaigns such as 'Ek ped Maa ke Naam' with diaspora support helping to accelerate the State's five year plantation targets.

RF shall also facilitate NRRs in supporting the construction of recharge shafts and water conservation structures at the Panchayat and Tehsil levels under the provisions of Karmabhoomi Se Matribhoomi Abhiyan (Jal Sanchay-Jan Bhagidari Scheme) and any other developmental initiatives in the field of Agriculture, Horticulture and allied sectors in coordination with the concerned departments.

VI. Pashu Kalyan

RF shall promote and facilitate NRR contributions towards animal welfare in collaboration with the Animal Husbandry Department, GoR and District Administrations. NRRs may contribute to the building of veterinary institutions, development and maintenance of animal shelters, donation of mobile veterinary units, equipment, X-ray, sonography machine, animal feed etc. and the organization of vaccination and health camps for livestock.

RF shall also facilitate NRRs in supporting the construction of shelters for stray male cattle in Panchayats under the provisions of the Panchayat Samiti Nandishala Jan Sahbhagita Scheme in coordination with the Department of Gopalan, GoR. RF will promote non-financial awareness drive such as free veterinary consultation.
